WHEREAS, the City of West Richland and the City of Benton City on July 24, 2012 executed a Interlocal Agreement For Street Sweeping Services; and



**AMENDMENT #3
INTERLOCAL AGREEMENT
BETWEEN CITY OF WEST RICHLAND
AND CITY OF BENTON CITY
FOR STREET SWEEPING SERVICES**

THIS AMENDMENT IS ENTERED into by and between the CITY OF WEST RICHLAND, a municipal corporation of Benton County, Washington, hereinafter referred to as "West Richland" and CITY OF BENTON CITY, a municipal corporation of Benton County, Washington, hereinafter referred to as "BENTON CITY", for street sweeping services, and is effective January 1, 2015 upon execution by both parties.

WHEREAS, the City of West Richland and the City of Benton City on July 24, 2012 executed a Interlocal Agreement For Street Sweeping Services; and

WHEREAS, Section 4(C), General Terms, states Benton City recognizes that annual written amendments to the hourly street sweeping rate in Attachment B on January 1st shall be necessary to allow West Richland to be fairly compensated for labor and equipment associated with street sweeping services; and

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is acknowledged, City of West Richland and City of Benton City agree to the following amendment to Attachment B as follows:

Attachment B

Street Sweeping Services

**2015 hourly rate, including labor, equipment, and administrative fee, shall be \$201.37 /hr.
(hourly rate to be charged from West Richland's shop to West Richland's shop)**

Rate to be amended annually on January 1st

West Richland and Benton City shall each approve this Amendment by appropriate motion, resolution or ordinance. Each party represents to the other party that it has the power and authority to execute this Amendment
