ORDINANCE NO. 941**

**AN ORDINANCE OF THE CITY OF BENTON CITY, WASHINGTON,  
ADOPTING THE BUDGET FOR THE FISCAL YEAR ENDING DECEMBER  
31, 2015.**

**WHEREAS**, the City Council of the City of Benton City, Washington, conducted a Public Hearing on November 4, 2014, and did consider the matter of the proposed budget, and no persons appearing to make objection to same and no objection having been filed with the City Clerk-Treasurer, and

**WHEREAS**, the proposed budget does not exceed the lawful limit of taxation to be allowed by law to be levied on the property in the City of Benton City for the purpose to set forth in said budget being all necessary to carry on the government of the City during said period,

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BENTON CITY, WASHINGTON, AS FOLLOWS:**

**SECTION I.** That required revenues and expenditures for the various departments and needs and the operation of government of the City of Benton City, Washington, for the fiscal year ending December 31, 2015, are fixed in the following amounts, to wit:



**SECTION III.** This ordinance shall be in full force and effect by January 1, 2015 after passage, approval and publication as required by law.




